Applicants will work closely with a supervising faculty member to conduct quantitative and/or qualitative research projects. Research duties may be performed at the ASU Tempe campus or in the field. The research assistant positions are .25 FTE (10 hours/week) for the 2023-2024 academic year. Research assistantships include a tuition remission and a stipend, .25FTE Research Assistants will receive half tuition remission.

- Regularly admitted to graduate degree program in counseling or counseling psychology
- Enrolled for at least 6 hours of graduate credit during each semester as Research Assistant
- Experience in quantitative and/or qualitative research methodologies

- Knowledge of major statistical software (e.g., SPSS, MPLUS, R, STATA)
- Coursework and experience with advanced statistical methods and measurement and/or advanced qualitative methods
- Research presentation or publication history
- Research as an important professional goal
