## Information on Internships

The [Internship Site List](#) is provided to assist students in seeking out currently approved Internship sites. The information contained in the document is accurate through the revised date listed on the front page. Although this document is revised annually, many of the sites may experience administration and services changes throughout the year. As a result, any changes that occur may not be reflected on the list until the next scheduled update. Please note that due to high turnover and continuous modifications to administration and services at these agencies, contact information may be changed, altered, or inaccurate. Please contact your internship course instructor or MC Internship Graduate Assistant (GA) to inform them of any changes in contact information that you may find.

This document briefly describes how to apply for CED 684: Internship. The Master of Counseling Training Director will present in the Master's Practicum seminar class within the first two month of each semester to provide prospective internship students with the necessary information relative to the Internship course application process. It is crucial that prospective interns attend this presentation and do not proceed with applying for internship solely based on the information provided in this document. Should you be unable to find placement at a pre-approved internship site, there is the option to submit a site for approval through the Clinical Committee. The [Internship Site Approval Checklist and Attestation](#) form must be submitted for consideration. **A minimum of two months is required for internship site review and approval.**

## Scope of Service

The Internship in Clinical Mental Health Counseling course (CED 684) is designed to improve the student's professional skills and to help the student synthesize learning by providing an opportunity and experience to become familiar with a variety of professional activities through an approved internship site. These should include a broad array of cross-cultural experiences.

Total hours required for the entire two-semester internship: **600 cumulative hours with 240 of the hours as direct service.**

Direct service is defined as:

- Individual and group counseling
- Couples and family counseling
- Delivery of psycho-educational training and/or workshops
- Crisis counseling
- Test administration/interpretation

The remaining hours are *indirect* service and include training, staff, administration, supervision, and additional training experiences the site supervisor and the student agree upon. Thus, ***the requirements for each 15-week semester are: 300 cumulative hours with 120 of the hours as direct service and an average of one hour per week of individual/triadic supervision*** (triadic supervision is considered one supervisor and a maximum of two student interns).

An average of one hour per week of clinical supervision must be provided specifically by an on-site supervisor who is either licensed as an LPC, LCSW, LMFT, or a Licensed Psychologist. Specifically, the assigned supervisor who will be interfacing on a weekly basis with the MC student intern must be independently licensed and have (1) a minimum of a master's degree, preferably in counseling, or a related profession; (2) relevant certifications and/or licenses; (3) a minimum of two years of pertinent professional experience in Clinical Mental Health Counseling; (4) knowledge of the program's expectations, requirements, and evaluation procedures for students; and (5) relevant training in counseling supervision. Alternatively, it is permissible for clinical supervision to be provided by a supervisor-in-training who is directly supervised by a supervisor-of-record who holds the above listed qualifications. If you have questions about your clinical supervisor's qualifications, please contact the Master of Counseling Training Director.

Interns are expected to have a wide range and combination of the following experiences at their sites: individual and group counseling, couples and family counseling, delivery of psycho-educational training and/or workshops, psychosocial assessments, DSM-5 diagnoses, access to diverse ethnic and cultural groups, crisis counseling, test administration, case conceptualization, and any other experiences that the site supervisor approves.

A weekly log of time and activities must be maintained and submitted as designated in the CED 684: Internship course calendar. The student, site supervisor, and internship instructor must sign it.

It is expected that one hour of supervision will occur during the week where any direct client contact hours are being counted on the weekly log. If the supervision hour must be cancelled for any reason, it must be rescheduled and made up so there is a minimum average of one hour of clinical supervision per week of direct client hours.

It is strongly recommended that site supervisors immediately alert Dr. Jamie Bludworth, Master of Counseling Training Director, regarding any professional disposition concerns, problems and/or violations of ethics. The internship instructor or Training Director will contact each site supervisor at the beginning of each semester to add any information needed and review rating procedure for evaluations. Please contact the Training Director at (480)965-6956 if you would prefer a person-to-person site visit.

Site supervisors will submit the [ASU Master of Counseling Clinical Evaluation](#) form twice (2x) per semester. The evaluation must be based on the site supervisor's observations of the intern's interactions with clients. Please make arrangements with your site supervisor, ahead of time, to ensure your evaluations are completed and submitted by their respective due dates. These evaluations are weighted heavily as part of your final grade for each semester of the internship course.

Toward the end of the internship, students will submit a formal evaluation of their internship site and supervisor.

Internship must be completed over two consecutive semesters. Of the 300 cumulative hours required each semester, 120 hours of those must be a combination of services that constitute direct client contact hours. You must enroll for three (3) credit hours per semester in one the follow sequences:

1. Fall and spring
2. Spring and summer
3. Summer and fall

Enrollment in CED 684: Master's Internship is **extremely time consuming**. Students should take into consideration the amount of time necessary to complete all assigned coursework as well as class time (group supervision) and travel time to and from your internship site. Given this extensive time commitment, the faculty advises that students enroll in no more than 12 credit hours total when taking internship. Students engaged in any internship placement must be enrolled for internship credit.

During internship, be sure to retain copies of all logs and evaluations for your own personal records. You will need these forms when applying for licensure. While the program retains these documents, this is as a back up to verify records, when requested. It is also strongly recommended that you keep copies of all class syllabi, as well as the [program handbook](#) from your cohort year.

It may occur that students do not have enough hours at the end of a semester; in this case they may continue at the agency until they obtain the required hours. For purposes of liability, they must be enrolled for internship credit the following semester. For example, if a student interns in the spring semester and does not meet the required 600 hours, that student may continue at the site (with Internship Instructor approval) during the intersession and into the summer. However, the student must enroll for internship credit during the summer. In other words, students can intern during the intersession only if they are enrolled in the subsequent semester.

*In the event of any questions, issues or problems regarding a student's internship site, the student is instructed to contact their internship instructor, as well as the site supervisor, immediately.*

## Internship Application Process

1. You must submit the [Application for CED 684: Master's Internship](#) to the Coordinator, CTC, Leah Capps: [leah.capps@asu.edu](mailto:leah.capps@asu.edu)
  - a. You are not permitted to submit your application for CED 684: Master's Internship form until you have received your mid-term ASU Master of Counseling Clinical Evaluation for your practicum course (CED 680). Your practicum clinical supervisor will determine whether you are ready to submit your application for CED 684: Master's Internship.
  - b. Submission of your application for CED 684: Master's Internship form does not guarantee approval to secure an internship site. Students may NOT commit to any internship site prior to being formally approved, by the faculty, as ready for internship. Faculty meet to discuss every student's readiness to advance to internship during the final four weeks of the spring and fall semesters. Decisions are made based on performance in CED 680: Master's Practicum and general academic performance in the program. This means that you may have to wait beyond the first day of class registration to receive notification of approval to secure an internship site and complete the [Internship Application and Site Supervision Agreement](#) form.
2. The student is responsible for selecting the internship site, scheduling and completing interviews, and completing all required paperwork.
  - a. You will have an opportunity to meet with the site supervisors and obtain information regarding approved internship sites at the internship fair, which occurs once per semester.
  - b. The [Internship Site List](#) is provided to assist you in this selection.
  - c. If you are interested in a site not already on the Internship Site List, you must follow the procedures of the [Internship Site Approval Checklist and Attestation](#) form must be

submitted for approval. All sites must be approved by CCP faculty. Please allow a minimum of two months for faculty approval on new internship site applicants.

3. Complete all information requested on the [Internship Application and Site Supervision Agreement](#). This form is available in the forms section of the MC program website. Names, addresses, telephone numbers, and email addresses must all be completed.
  - a. You and your site supervisor will develop the responsibilities, experiences, goals, and skills that are called for on the application form.
  - b. Signatures are required from your site supervisor and the internship coordinator/instructor.
  - c. When all of this is completed, make a copy of the form for your records and turn the original form in to the internship instructor.
  - d. Students should expect to undergo background checks at their sites.
4. Once you are approved for enrollment for CED 680: Master's Internship, a registration override will be processed on your behalf and you will be notified of when to enroll in the course.
5. You will be required to provide proof of [ACA insurance](#) coverage, prior to starting your internship work.
  - a. While you are enrolled in CED 684: Master's Internship, you will have liability insurance through Arizona State University, however, you are also required to purchase your own professional liability insurance. The ASU Counseling Program requires that you register as a member of the [American Counseling Association \(ACA\)](#), as this membership includes professional liability insurance, along with other professional development benefits.

The internship experience is to provide the student with the opportunity to apply helping relationship skills under qualified supervision in an applied organizational environment, while at the same time contributing to the mission of the organization. As such, the student intern, site supervisor, and faculty/doctoral student supervisor agree to all of the following:

**THE STUDENT AGREES TO:**

1. Adhere to the ACA code of ethics.
2. Document a schedule with the site supervisor to work in the organization for a minimum of 300 hours during each semester (2 semesters), normally twenty (20) hours per week, across the duration of each 15-week semester. Interns must complete 120 hours of direct client contact and 180 hours of indirect services such as case notes, supervision, evaluations, and services deemed necessary for that site each semester.
3. Observe the working rules and professional standards of the organization under the supervision and to provide a weekly log during every supervision accounting for time spent accruing direct and indirect hours at the site.
4. Observe the requirements of the internship course as outlined in the course syllabus.
5. *Provide site supervisor with a copy of the course syllabus during each semester of enrollment.*
6. Provide the MC Program Internship Instructor with a revised form should the site supervisor change at any time.

**THE SITE SUPERVISOR AGREES TO:**

1. Adhere to the code of ethics associated with the supervisors' professional license.
2. Provide the ASU Intern with a caseload to include a reasonable combination of individual and group client hours. Specifically, the site agrees to provide a minimum of 8 direct client hours per week.
3. Verify via signature/initials the student interns' documentation of weekly hours via student provided log.
4. Be identified as the designated "Site Supervisor;" and in this role, is identified as the person responsible for providing direct supervision to the student for a minimum of one hour per week (All supervisors of record must hold at least a Master's degree and be licensed in the State of Arizona in Counseling or a related field).
5. Verify whether they have received training in clinical supervision (included in this agreement).
6. In consultation with the supervised intern, document and provide supervisee with ongoing feedback regarding their demonstrated knowledge, skill, and professional dispositions.
7. Schedule periodic formal evaluative sessions throughout the supervisory relationship. Specifically, to complete a formal written evaluation of the student's knowledge, skill and professional dispositions twice during each semester using the evaluation form provided by ASU's Counseling Program and to submit said evaluation with wet or verified electronic signature to both the student and the CED 684 Internship Instructor. ***NOTE: written evaluations must be based on audio/video recordings or live supervision methods of the student interns' interactions with clients.***
8. Contact the CED684 Internship Instructor regarding any performance related concerns as soon as they arise.
9. Keep a copy of this agreement.

**THE FACULTY/DOCTORAL STUDENT SUPERVISORS AGREE TO:**

1. Adhere to the code of ethics associated with the supervisor's professional license.
2. Meet weekly for at least 1.5 hours for supervision, with a focus on promoting the development of supervisee's professional disposition, clinical competence and professional counselor identity via written and/or verbal feedback
3. Provide weekly group supervision during scheduled class time on campus
4. Provide academic content for the supervisee's Internship course as outlined in the course syllabus
5. Consult with supervisee's site supervisor at any time, and to document formative (midterm) and summative (final) evaluations of the student's professional dispositions, counseling performance and ability to integrate and apply knowledge
6. Consult with supervisee's site supervisor as needed to determine final grade for the course.

- A description of the context in which student interns will conduct counseling/therapy with clients (e.g., locked facility, group home, licensed clinicians on site while intern is with clients).
- Summary of required internship activities/experiences provided at the site (i.e., individual and group counseling, family counseling, case conceptualization, treatment planning, DSM-IV/5 diagnosis, access to diverse ethnic and cultural groups, crisis counseling, test administration, and psychoeducational training).
  - Please include a brief overview of the onboarding/training/orientation process expected of students and indicate when they will be eligible to begin training.
- **Brochure(s)** with thorough description of the counseling program(s) at the site, including contact information and web address.
- **Professional résumé or vita** describing the supervisor's/supervisors' credentials, including dates of degree conferral.
- **Copy of the site supervisors' license(s)**

**Please check each box below indicating the site agrees to the following:**

- Provide student intern with required number of contact hours to fulfill course requirements each semester (8-12 direct client contact; minimum 20 hours per week total)

## Internship Policy

Students who do not complete their hours by the time grades are due have until the week prior to the start of the next semester to complete their hours **if the internship instructor approves of their incomplete status**. This means the instructor requires a week for all grade changes to be evaluated and submitted.

If students are not able to complete their hours before the start of the next semester, they must be enrolled in internship to maintain liability coverage with ASU. This means that students who are enrolled in CED 684 in the spring and who do not finish their hours by the final day of classes will be required to enroll in CED 684 internship over the summer.

\_\_\_\_\_4. When a mutually agreeable training program has been arranged, ask the Site Supervisor to complete the Letter of Agreement portion of the Application. You, the Site Supervisor, and the Internship Instructor must all sign the Application. Be sure to include complete mailing address, names, titles, organization, phone numbers, e-mail addresses, and zip codes of all concerned parties. This is needed for mailing purposes.
